of medications




In January 2018, FDA reported the 2018 priorities with initiatives to ease and support any manufacturer providing medications at reduced costs to the ad-

vantage of the patients.

This includes being open for new ways, adjusted requirements and new sources, and promoting generic drug competition, which can facilitate reduced costs to provide the needed medication.

It is still yet to be seen what precisely will be recommended and accepted as change.





# Eye drop bottles adapted to new FDA requirements

In response to the FDA's warning about loose tamper-evident rings on eye drop bottles, Gerresheimer has modified the closure system for its Type A dropper bottle (LDPE). Now the tamper-evident ring stays firmly affixed to the bottle once it has been opened.

The tamper-evident is important because it tells the user that the product hasn't been opened since filling. This guarantees that the bottle contains the original pharmaceutical and that nobody else has previously opened or used it. Although that's important with all medications, it's particularly important with eye drops, which shouldn't be administered if they are contaminated.

Before the modification, the tamper evident ring was loose on the bottle neck after opening. Unless the user removed the ring, it constituted a potential hazard. That's why fixing the tamper evident ring in place is a good idea that improves safety.

#### Main characteristics:

- Design of TE-ring modified
- TE-ring will be blocked onto the bottle
- All dimensions, properties and material are kept the same
- Based on experience from our System B
- No changes on the inside of the bottle

### New warehouse in Hyderabad, India

To fulfill the logistic requirements from our customers and in order to be closer to the pharmaceutical companies, we have now established a warehouse in Hyderabad, India.

### Extend our global footprint to the US

Gerresheimer Plastic Packaging expects to be fully operational with both solid and ophthalmic products in the US from Q2, 2018.

The production will take place in our subsidiary company, Centor, which is located in Berlin, Ohio and all products will be manufactured under clean-room conditions.

With this expansion we will be closer to our customers and we believe we will be able to support our customers better regarding logistics.
